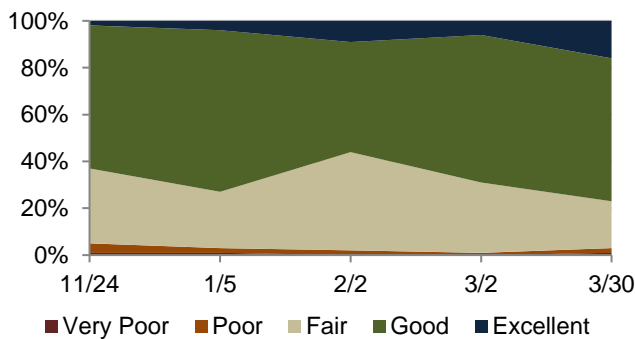

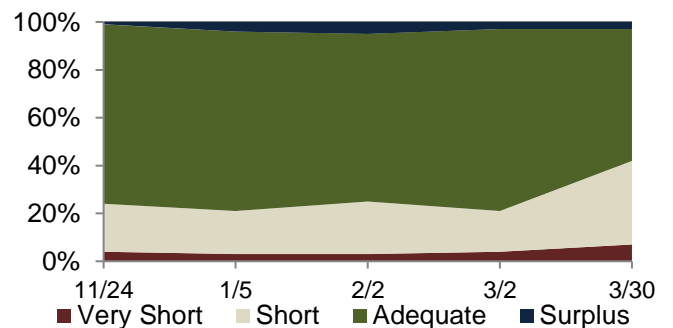

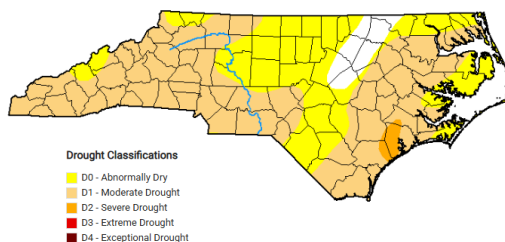
### WINTER WHEAT CONDITION



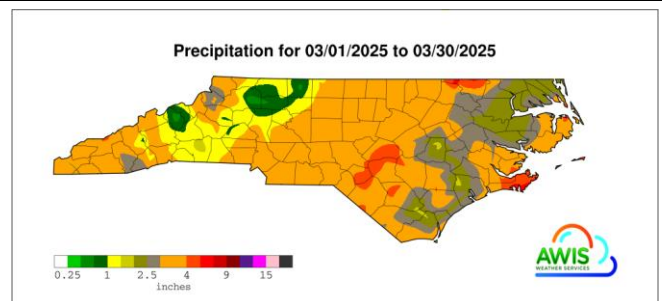
### TOPSOIL MOISTURE PERCENT
