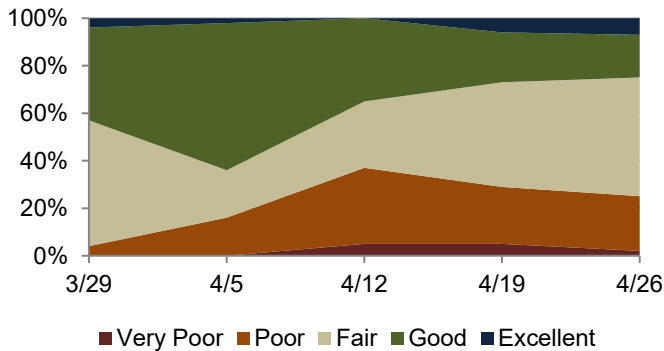

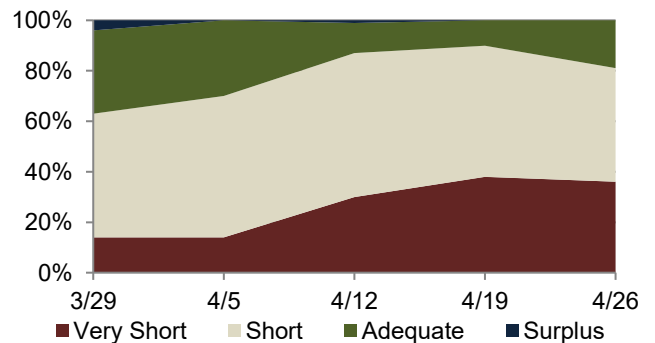

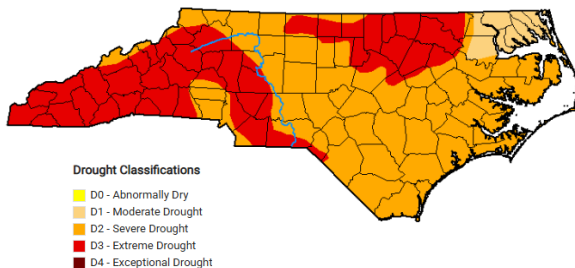
OATS CONDITION



TOPSOIL MOISTURE PERCENT

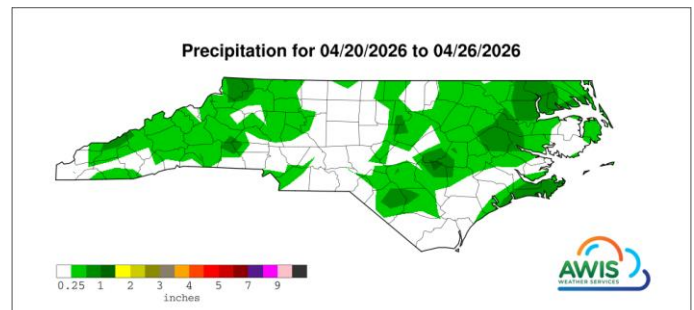


Map depicts current drought conditions as of April 21, 2026.
